FIRE PREVENTION POLICY AND LIFE SAFETY PROGRAM FOR THE WOODS (DEPARTMENT 78)

THE GOAL

The goal of the Fire Prevention Policy and Life Safety Program for The Woods (Department 78) is to educate Lake Forest II homeowners about our fire prevention program. The program consists of two sections:

I. MANDATORY MEASURES

The Mandatory Measures are enforceable by the Association's Community Services Department.

A. Article III, Section 3.02H, of the CC&Rs

Maintenance of Lawn Plantings: Each owner of property within Single-Family areas shall keep all shrubs, trees, grass and plantings of every kind on his property neatly trimmed, properly cultivated, and free of trash, weeds and other unsightly materials. (Excerpt)

B. <u>Lake Forest II Master Homeowners Association Vehicle and Parking Rules</u>

Vehicle and Parking Rules: Lake Forest II Master Homeowners Association has its own Vehicle and Parking Rules, which include some portions of the California Vehicle Code. (Copies of the Lake Forest II Vehicle and Parking Rules, and a copy of the California Vehicle Code, are available at the Association offices.)

Listed below is important information regarding width clearance for private and public streets, which allows adequate access space for fire and emergency vehicles, equipment and operations.

- 1. Parking is <u>not permitted</u> on the following Lake Forest II private streets and cul-de-sacs, as the width clearance is less than twenty-eight feet (28'). These restricted parking areas will be identified by signage provided by the Lake Forest II Master Homeowners Association.
 - a. Eucalyptus Lane in two (2) different locations
 - b. Intersection of Heartwood Circle and Trailview Terrace

- c. <u>Intersection of Sleepy Hollow Terrace and Ironbark</u>
- d. Wandering Lane between the cross streets of Shady Rim Circle and Brittlewood Circle.
- 2. Parking <u>is permitted</u> on one side only of private streets and cul-desacs that are a minimum of twenty-eight feet (28') wide.
- 3. Parking is permitted on both sides of the streets that have a minimum width of thirty-six feet (36').
- 4. Parking is not permitted within fifteen feet (15') of a fire hydrant.

C. <u>Chimney Spark Arresters</u>

Spark arresters must be installed on all chimneys of all homes in Department 78 (The Woods). For information, call the City of Lake Forest Community Development Department, Building Division, at 461-3460, or the Orange County Fire Authority at (714) 744-0400.

D. No Smoking in The Woods

For safety reasons, smoking is prohibited in The Woods common areas and ravines.

E. Motor Vehicles Prohibited in Common Areas

- 1. All motorized vehicles, including motorcycles, motor scooters, all-terrain vehicles (ATVs), or vehicles with catalytic converters, except for Association Maintenance vehicles, are banned from operation in any of the Lake Forest II Master Homeowner Association common areas.
- 2. The fine for violation of this policy shall be \$125.00 for the first offense.

II. RECOMMENDED MEASURES

The Lake Forest II Master Homeowners Association recommends the following:

Fire Prevention Materials & Services: The Association encourages homeowners to obtain referrals for all fire prevention-related services, materials and contractors.
